***I understand a surrender form, vet records, and picture need to be submitted before CCHS will consider taking my animal. My pet is not in the CCHS system until it has been officially approved by the CCHS feline or K9 officers. Any discrepancies given in the information may result in CCHS declining the surrender of your pet(s).**

***By signing below, I acknowledge that I am surrendering my interest in the animal. I recognize that from this point forward, all decisions regarding the disposition of this animal are at the sole discretion of Clinton County Humane Society.**

***I hereby surrender this animal to the Clinton County Humane Society. It is acknowledged that the animal is mine at the time of surrender and for whatever reason, I am no longer able to care for it. I am being as honest and truthful about the information provided so it will help match this animal with the appropriate foster/new home.**

***I understand that a surrender fee(s) will apply and are used to help pay for the cost of the pet. Fees can be lowered/waived under the discretion of the Feline or K9 officer. This applies to any returning CCHS animals after their 14 day grace period.**

Dogs: \$50 per dog over 4 months, \$25 per puppy under 4 months, \$100 for mom & litter if pups are under 4 months old.

Cats: \$25 per cat/kitten \$50 per litter **Additional monetary donations are always welcome******
